## Photo submission policy:

- The contest is open to all Oregon residents
- Submission deadline: October 1<sup>st</sup>, 2008
- Winners will be notified by November 1<sup>st</sup>, 2008; top 10 winning photos will be published at the German American website, the German American Journal and displayed at Lorenzo's restaurant through the month of January 2009
- Photographers may enter up to five photographs. Each entry must be listed on the entry form.
- A completed entry form must accompany the photographs. Entries must be signed and dated. Only entry forms with complete, accurate legible information will be considered eligible.
- All photographs must be in sharp focus. Prints must be at least 5-by-7 inches or larger and be printed on photographic paper. Images printed on ink jet paper will not be accepted.
- All photographs, entry forms and releases must be post-marked by October 1<sup>st</sup>, 2008. Late entries will not be considered.
- Photographs must be previously unpublished. Photographs that have been published in any form prior to entry into the contest will be disqualified.
- Damaged photographs will not be accepted. Prints cannot be stapled or folded. Tape must not be attached to the front of the photograph. Any violation of this provision will result in disqualification of the entry.
- Stickers identifying the photograph should be placed on the back of the photograph, and should note the location, event and other pertinent information.
- By submitting a photograph, the photographer is certifying that individuals in the photo have agreed to release the use of their image to this contest.
- The German-American Society of Portland or their agents or assigns are not responsible for late, lost, damaged, destroyed or misdirected entries, or for miscommunications, misdirected transmissions, or other errors of any kind whether human, mechanical or electronic.
- Photos will not be returned. All other rights remain with the photographer.
- Prizes will be awarded only to entries that the contest judges deem worthy. The judges' decision is final. Employees of the German-American Society of Portland and the judges are prohibited from participation in the contest.
- Any taxes or additional expenses associated with the awarded prizes are the responsibility of the winner.
- The contest is void wherever restricted or prohibited by state or local laws.
- Contest entrants agree to abide by the terms of these Official Rules and by the decisions of the judging organization, which are final on all matters pertaining to contests. The return of any prize/prize notification as undeliverable may result in disqualification and selections of an alternate winner.
- By entering, participants release and hold harmless the German-American Society of Portland, as well as any directors, officers or employees from any and all liability for any injuries, lost or damage of any kind arising from or in connection with the contest.
- If for any reason the contest is not capable of being conducted as planned, including any causes beyond the control of the administrators of the contest, the German American Society of Portland reserves the right, at its sole discretion, to cancel, modify, suspend or terminate the contest without notice to the entrants.
- Entry into the photography contest does not create any vested right or interest for the participants in the prizes offered for the contest.
